1.0: CALL TO ORDER:

A letter was received from the County Clerk/Election department. The election in November will be mail in only. They will still need places for voting centers, but for an extended amount of time. Chief Stipes says if we are still under a shelter in place order that this is a no go. As for the extra days this is up in the air for now.

8.0: COMMITTEE REPORTS:

8.1: Chiefs Report:

- Calls for service: 18: 13-EMS, 1-MVA, 2-public service, 1-vehicle fire, 1-tree in wires,
- The freezer in the kitchen has gone out. Then the water heater broke down. The water heater was replaced but for now the freezer has not be fixed or replaced.
- Servicing on all vehicles has been completed this week.
- BFAA academy started back up the first week of May.
- Weed whacking has been done.
- There is a meeting this week of the Auditor team

- Looking to start training again the first week in June.
- The EMT recertification needs to be done.
- Salary survey to CFAA. This year it has been changed with Workers Comp, Unemployment and SS all to be added in.
