9.1: Administration:

- Chief Maxwell completed annual payroll calculations based on 408 total incident responses and 42 drills.
- A Halloween Trick or Treat was hosted for 51 children.
- Performed Siren Saturday test that was set off remotely.
- Sizing for wildland PPE continues.
- Uploaded NFIRS data.
- Signed SCC Fire Investigation Task Force MOU for duty coverage.
- Conferenced with SCR911 to address incident notification during power outages.
- Attended County Chiefs meeting.
- All Claims, Deposits and Journal Entries were processed in a timely manner.
- Outreach to settle Stale Dated Warrant liabilities by G. Hicks ongoing.

9.2: Apparatus: All apparatus is in service.

- Reprogramed 8 pagers for alerting access by Cal Fire.
- Reassigned 2403 and 2400 vehicles in Dispatch system. Decal and cradle point change completed.
- Surplus Engine sale negotiated with a private buyer for \$7500.

9.3: Training:

- Hosted California State Firefighters Association Forcible Entry training class for 20 Firefighters. Zayante had 9 personnel in attendance.
- This month's training included low angle rescue exercises and Air Aware Firefighter rescue and survival techniques.

9.4: Prevention:

- Volunteers assisted in Fire Prevention Week at Quail Hollow School.
- Conducted a Home Ignition Zone inspection at 8266 West Zayante Rd and 1070 Wilderfield.
- Coordinated the Gate lock exchange for Lichen Oaks Ranch for Valley Knox locks and Bridge recertification received.

9.5: Stations and Grounds:

- Completed one day of chipping to increase road visibility on property. Also removed two trees impeding the helispot.
- Opened drainage ditches and cleaned roof gutters in preparation for winter storms.
- Recontacted SLVWD for Box Gulch mitigation project.
- Repaired Fire Burn Trailer Ventilation scuttle.
- Changed street warning light from auto to manual to increase driver awareness.
