Subject: Purchase of Used Type 6 Ford F550 Wildland Engine

Background: After review of existing strengths, weakness's and age of our fleet it was determined that the District was investing significant funds towards annual maintenance and repair of dated fire apparatus. As a result, the Board surplused two engines and two light vehicles to reduce overhead expenses.

In response to the sale of E2412 located at Station 3 we reviewed the existing market inventory of used apparatus with an eye towards smaller, more manuverable units better situated for the Upper Zayante Canyon.

A 2006 Ford F550 surplused from City of San Jose Fire Department was located and a due diligence inspection was conducted noting a turbo issue and oil leaks. The Reseller runs a commercial truck restoration business and completed noted repairs including providing the work invoice meeting our satisfaction after a second inspection, road test and pump operation.

A verbal agreement with deposit was issued and the Board of Directors will have a Resolution to transfer Capital Outlay funds to the General Budget to complete the transaction.

Additional equipment is available from the surplus of E2412 and E2414. Technology equipment is available from the sale of Rescue 2465. Additional expense will be incurred to demobilize the technology and reinstall it on the Type 6 unit.
